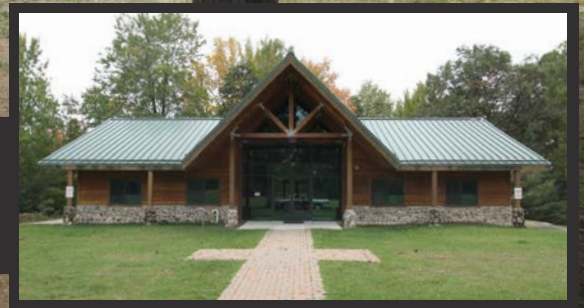

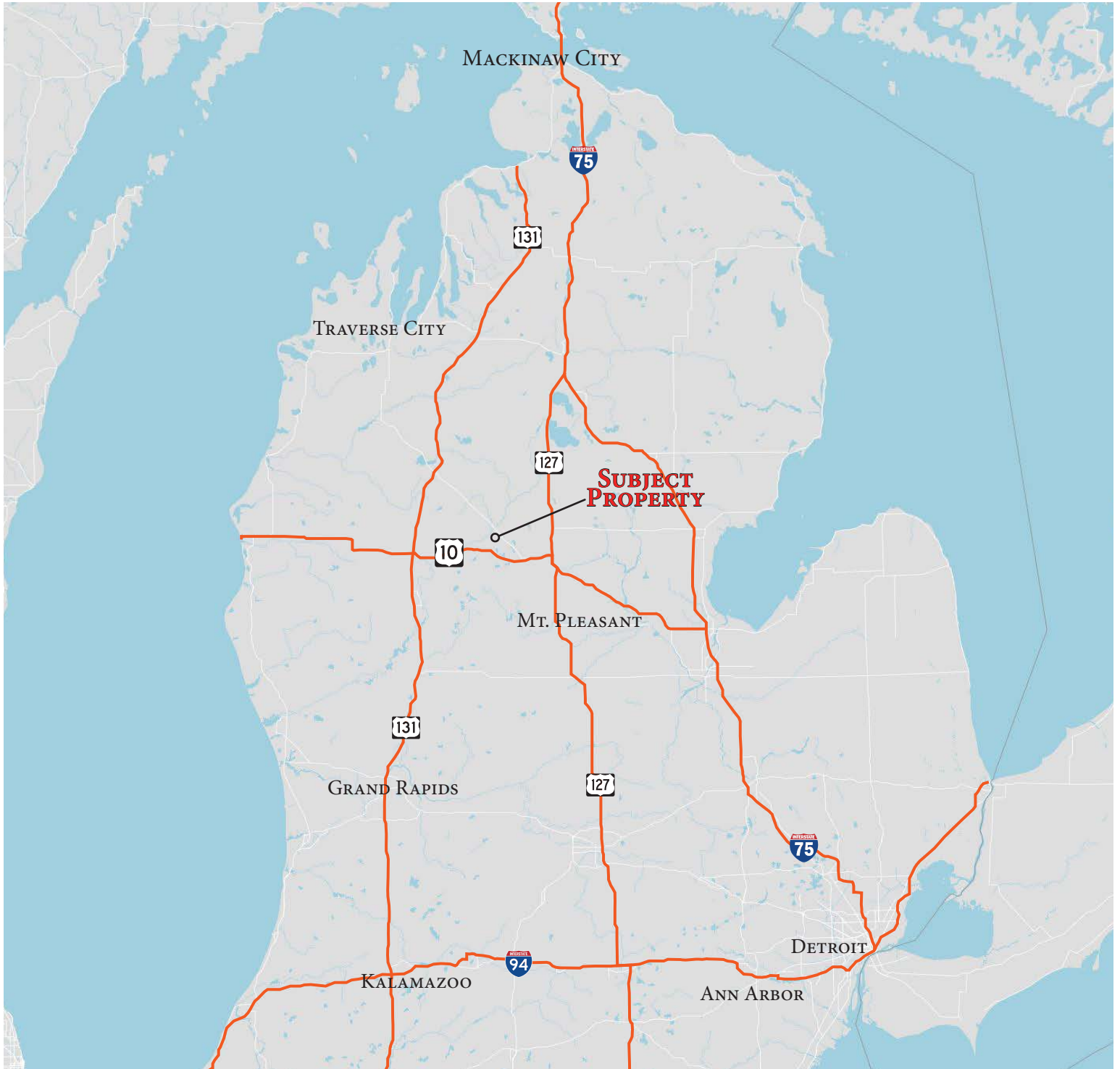

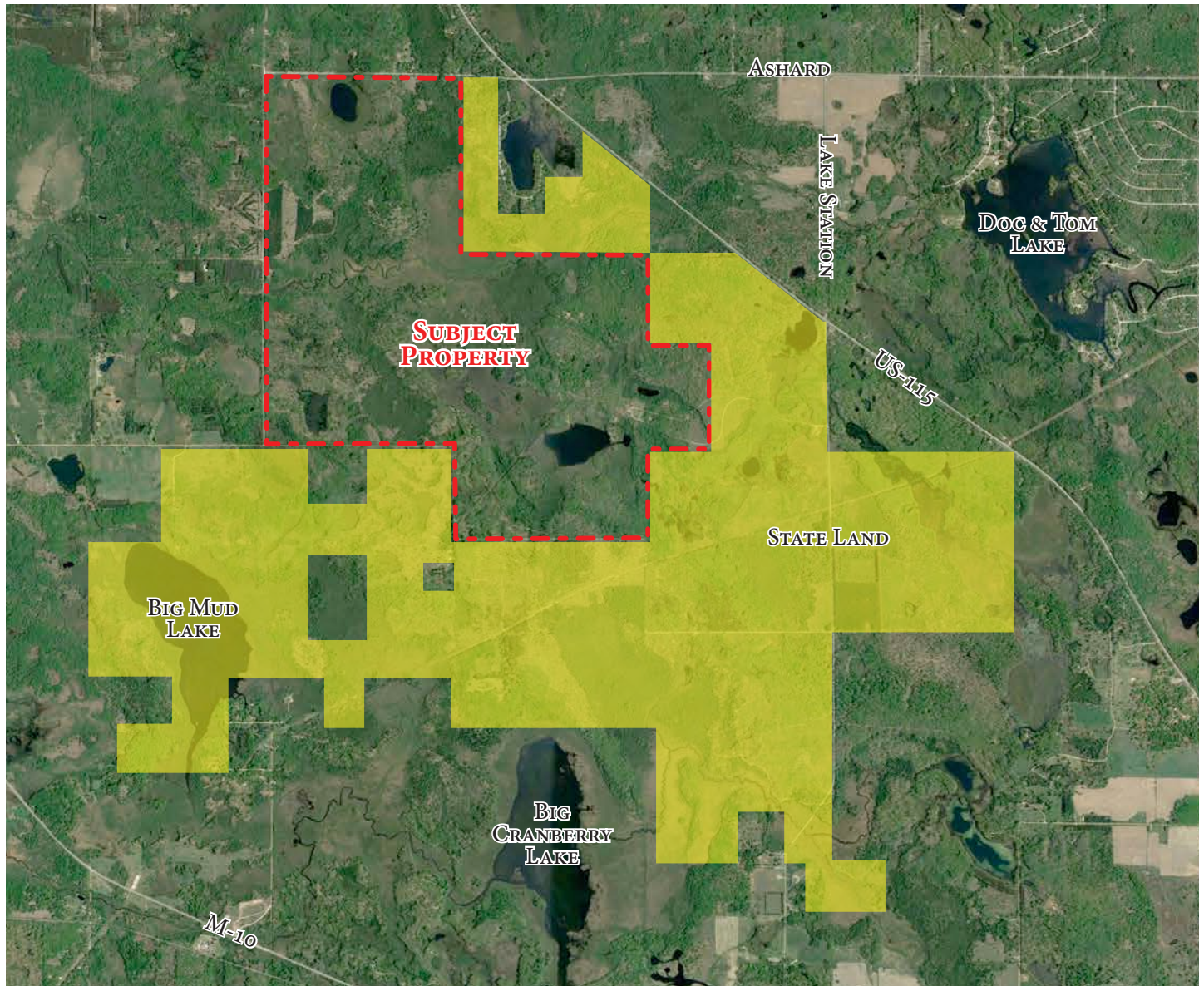
REGIONAL MAP

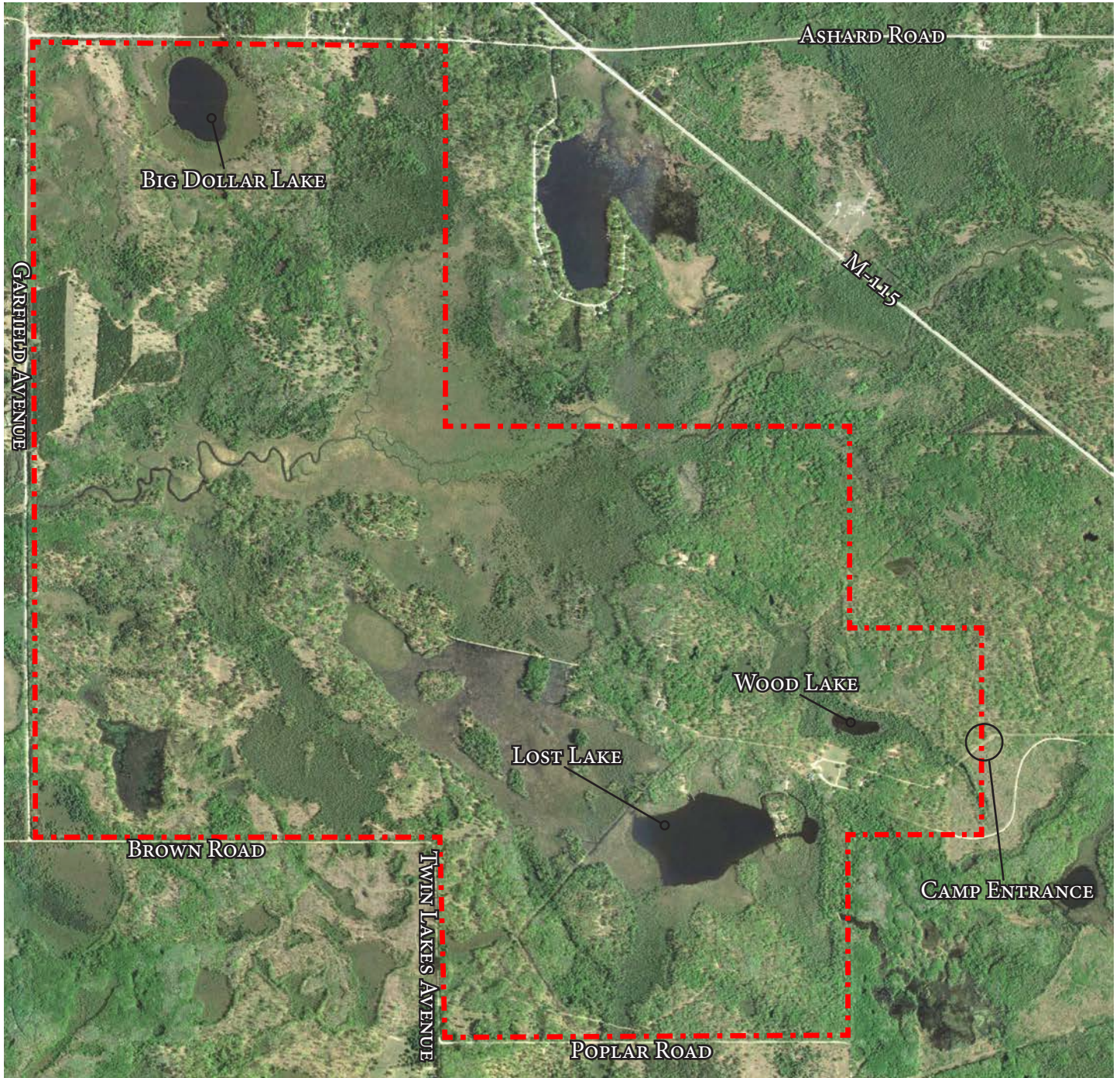
AREA MAP

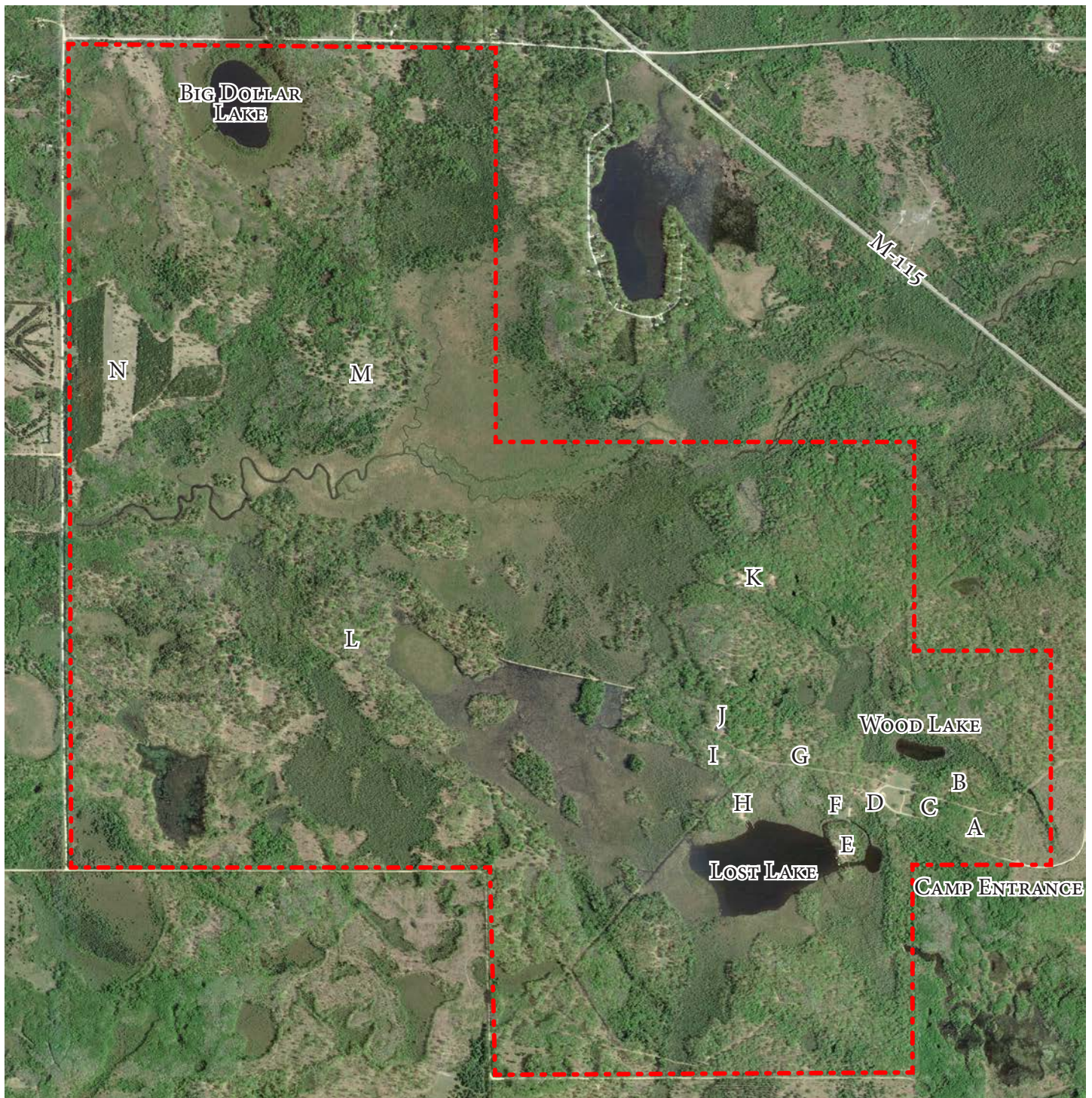
