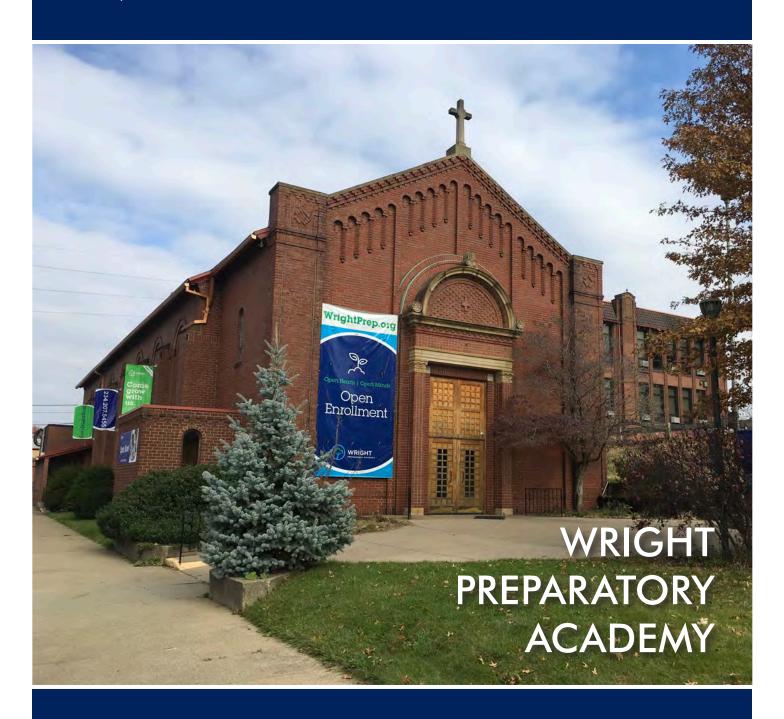

THE TENANT

Located near the interchange of Mahoning Avenue & Supieror Avenue Wright Preparatory Academy (Wright Prep) is a small charter school serving students who would be traditionally enrolled in grades K-8, aged 5-14. These students may have fallen behind in earning credits, have difficulty passing state required tests, are at risk of dropping out of school, or just need a new environment in which they can succeed, See http://www.wrightprep.org.

Wright Prep is a publicly-funded charter school established under Chapter 3314 of the Ohio Revised Code. The school is a public school and students enrolled in and attending the school are required to participate in MAP testing school wide, take Ohio Achievement Assessments, and any other examinations prescribed by law.

School hours are between 9:10am -4:00pm. Every Wright Prep teacher is certified to teach in the subject and grade-level to which they are assigned. All staff are certified "highly qualified" or "HQT."

Wright Prep opened in 2016. There are 10 teachers and staff members to support the students. Their commitment to their students and dedication to impacting their education through innovative methods makes Wright Preparatory Academy unique.

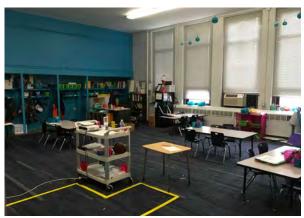

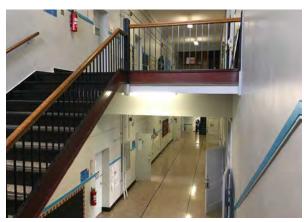

AREA OVERVIEW

Canton is located in northeastern Ohio. The City of Canton provides its residents with many benefits of big-city living while maintaining its charm as a medium-sized Midwestern town. Canton is home to many well-known national landmarks like the NFL Pro Football Hall of Fame, the William McKinley Presidential Library/Nation Monument, and the Nation First Ladies Library and Research Center.

World-class hospitals and five area universities provide excellent care and an enriching learning environment while the serenity of the public parks and nature preservations allow Cantonians time away from the hustle and bustle of city living.

Founded in 1805, Canton originally functioned as a prominent manufacturing center which expanded during the turn of the century due to industrialization and the addition of railroad lines. After the decline of heavy manufacturing, the city's industry diversified in the areas of service, retail, education, finance, and healthcare sectors.

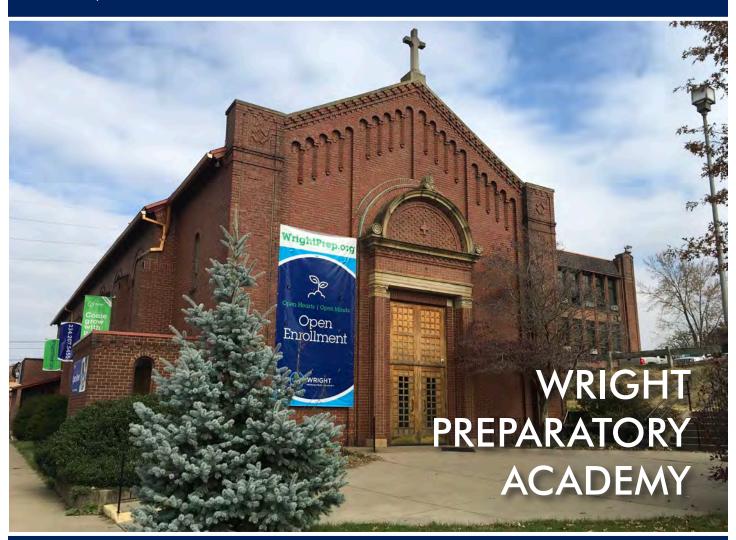
Crystal Park is one of the best-known neighborhoods in terms of the older, working income neighborhoods in Canton. It was built to provide affordable and quality housing for workers at the nearby factories. Those workers drove the incredible growth of Canton just before and after World War I. The neighborhood benefited from excellent transportation to downtown and also by two major roads, Mahoning Road NE and Harrisburg Road NE.

The properties at 1500 Superior are located in Crystal Park and were built in 1921 (former church) and 1930 (school) as the St. Paul's Catholic Church and School. Due to declining membership, the church closed and merged with another parish in 2011. The buildings are home today to Wright Preparatory Academy.

Currently the city of Canton is working to help revitilize the neighborhood with on-going road improvements on Mahoning Avenue.
